

## Terms and Conditions:

- i. Only 1 Parent/Guardian will be allowed per Participant inside the Audition venue gate.
- ii. Parent/Guardian shall ensure that all true copies of the above documents are provided by them to enable the Participant to participate in the Audition.
- iii. By virtue of entering the venue Parent/Guardian agrees that such Parent and the Participant shall be captured on camera and the Organizers shall have the complete authority to use the footage in any manner and form as recorded by the Organizers as they deem fit, for the Show.
- iv. Only the Parent/Guardian and Participant for whom the Parent/Guardian has done the registration and who has been provided with a valid unique identification number shall be allowed for participation in the Audition.
- v. The entry for the Audition venue will close at 4.00 pm sharp and any Participant who fails to report at the Audition along with their Parents/Guardians at the venue desk shall lose his/her chance to participate.
- vi. No refreshments or food apart from water shall be provided by the Organizers and the Parents/Guardians are requested to carry dry snacks like biscuits / cakes etc. for their child aspirant to participate in the Auditions.
- vii. Organizers will not be responsible towards any expenses incurred by the Parent/Guardian of the Participant for the auditions including but not limited to any travel and accommodation expenses incurred by them.
- viii. Decision of the judge(s) are final and cannot be called into question and/or contested for any reason whatsoever.
- ix. In light of security at the venue, the Parent/Guardian may be frisked and belongings physically checked by the concerned security staff of the Organizer.
- x. Parent/Guardian along with the Participant will be allowed to audition only once, in any city, any re-entry in another city would be automatically disqualified.
- xi. Parents/Guardians shall ensure the safety, security and well-being of the Participant and Organizers shall not be in any manner liable for any arrangements, whatsoever.
- xii. Parent/Guardian shall ensure that once the Participant enters the venue gate, the Participant shall abide by the various terms and conditions and requirements and/or agreements as asked for by the Organizers, failing which the Organizers shall have the absolute discretion to disqualify the Participant and Participant along with the Parent/Guardian may be asked to leave the venue of Audition.
- xiii. At all times, Parent/Guardian agrees that the decisions of the Organizers shall be final and binding and they shall not have any claim against such decisions taken by the Organizers in respect of the Audition and the Show.
- xiv. Certain Participants may have Jump the Que passes, handed over by the Organizers, which would allow the holder of the same to bypass any que for the Auditions and Parents/Guardians hereby agree not to question the same and/or raise any claims thereto.
- xv. Parent/Guardian shall sign and execute all documents and agreements as required by the Organizers to enable the Participant to participate in the Audition and/or the Show.
